CONFINED SPACE RESCUE: LET'S MAKE A PLAN

Jerry Eslick, PRI Rescue

Rescue planning is critical; an unplanned rescue could be the attendants' last one if it is not thoroughly planned. Therefore it is required that an emergency response plan be prepared prior to anyone entering a confined space. A plan shall be written and established by the CSRT to address the response, to identify potential emergencies and to provide for timely evacuation, retrieval or rescue of entrants in a permit-required confined space. The plan must include: the known hazards identified; tools, lighting, communications and atmospheric monitoring and test equipment that will be used in hazardous or classified locations; limited room and access or configuration; PPE; ground fault circuit interrupters (GFCI); permits; and retrieval equipment.
